The 11th International Public Forum-Dialogue
"NUCLEAR ENERGY, ENVIRONMENT, SAFETY-2016"

On the initiative of the Public Council of Rosatom State Corporation on 22-23 November 2016, the 11th International Public Forum-Dialogue "Nuclear Energy, Environment, Safety-2016" will take place.

The organizers of the Forum-Dialogue are the Public Council of Rosatom State Corporation, Rosatom State Corporation, the Federal Environmental, Industrial and Nuclear Supervision Service (Rostekhnadzor), The V.I.Vernadsky Non-governmental ecological foundation, Scientific Research Institute of Ecological Problems.

The Forum-Dialogue will be held in cooperation with the International Atomic Energy Agency and with the support of the Russian Academy of Sciences, the Public Council under Rostekhnadzor, Interregional Environmental NGOs 'Green Cross', 'Green Life', 'Greenlight'.

Cooperation within the framework of international organizations, such as the International Atomic Energy Agency, the Nuclear Energy Agency of the Organization for Economic Cooperation And Development (OECD/NEA) is important for the development of nuclear energy, enhancing its safety and security. International cooperation is also an effective instrument for the implementation of the research conducted to enhance the safety of nuclear power use.

The most important prerequisite for the implementation of nuclear projects is the confidence of the population, non-governmental organizations, local authorities, in the information provided by representatives of the nuclear industry, scientists, state authorities.

The International Forum is traditionally a venue for meetings and discussions of the Russian and foreign experts, representatives of the nuclear industry and the public on the most important issues related to the use of nuclear energy. This year the discussions will be focused on the issues of the development of environmentally safe nuclear power, including the currently topical questions of nuclear facilities decommissioning and rehabilitation of the sites. For the first time, the state's effective management of the safety of nuclear power will be in the Forum agenda. Traditionally, a dialogue with all stakeholders will be organized at the Forum.

- academic and branch science, experts in the nuclear industry
- public authorities supervising nuclear and radiation safety;
